
A PART OF THE NE $\frac{1}{4}$ OF SECTION 24, TOWNSHIP 16 NORTH, RANGE 4 WEST OF THE INDIAN MERIDIAN, LOGAN COUNTY, OKLAHOMA. MORE SPECIFICALLY DESCRIBED AS: LOT NINETY-NINE (99) OF THE LANDING AT CEDAR VALLEY SUBDIVISION IN GUTHRIE, LOGAN COUNTY, OKLAHOMA ACCORDING TO THE RECORDED PLAT THEREOF.
